

What are the new refund rules for cruises?

New federal rules, Call+1(866)-228-3050 implemented by the Federal Maritime Commission, mandate that cruises departing from the U.S. are entitled to a cash refund, not just a future cruise credit, +Call+1(866)-228-3050 if the voyage is canceled or delayed by three or more days.

New U.S. rules (2022) mandate cash refunds Call+1(866)-228-3050 for cruises canceled or delayed 3+ days by the line Call+1(866)-228-3050, covering all fees, not just credit; however, passenger-initiated cancellations still follow individual line policies with escalating penalties Call+1(866)-228-3050, often shifting to Future Cruise Credits (FCCs) as you get closer to sailing, with specific timing depending on cruise length and line Call+1(866)-228-3050.

1. Federal Maritime Commission (FMC) Refund Call+1(866)-228-3050 Requirement

If a cruise line cancels a sailing entirely (not your choice) Call+1(866)-228-3050, passengers are entitled to a full refund of all amounts paid (not just a portion of the cruise fare).

The cruise line must issue that refund within about 60 days of cancellation Call+1(866)-228-3050.

These rules apply to bookings Call+1(866)-228-3050 made on or after the effective date of the regulation.

2. Cruise Line Call+1(866)-228-3050 Cancellation & Refund Policies (You Cancel)



Sliding Penalty Scale — Standard Refund Structure

Most major lines (Carnival, Royal Caribbean Call+1(866)-228-3050, etc.) use a tiered penalty schedule based on how far in advance you cancel:

Far in advance (e.g., 75–90+ days before sailing) Call+1(866)-228-3050: Full refund of the refundable portion (deposit refundable unless deposit is non-refundable).

Mid window: Partial refund — Call+1(866)-228-3050 typically a percentage of the total fare (e.g., 50%–75%), increasing the closer you get to departure.

Close to departure (often <30 days): Call+1(866)-228-3050 No cash refund — you may only get back government taxes/fees and prepaid extras Call+1(866)-228-3050.

3. Non-Refundable Deposits & Fare Types

Cruise lines now more commonly offer non-refundable Call+1(866)-228-3050 deposits or fare types as the default:

If you choose a non-refundable fare/deposit Call+1(866)-228-3050, you won't get that amount back even if you cancel well before the final payment deadline.

Some lines are shifting non-refundable deposits to be the default for new bookings Call+1(866)-228-3050 unless you pay extra or choose a specific fare type.

4. Future Cruise Credits (FCC) Instead of Cash Call+1(866)-228-3050

FCCs let you apply Call+1(866)-228-3050 the amount you've paid toward another cruise (often with an expiration date, e.g., within 12–24 months).

Sometimes a service Call+1(866)-228-3050 fee is deducted from the FCC (e.g., Carnival may charge ~\$50 per person on refundable cancellations before final payment).

FCCs are usually more flexible than strict cancellation penalties but are not the same as cash refunds Call+1(866)-228-3050.



5. Exceptions & Other Refund Rules Call+1(866)-228-3050



Cruise Line Cancels or Delays

No-Shows

"No show" (failing to board without cancellation) usually results in no refund at all Call+1(866)-228-3050, except for certain refundable elements like government taxes/fees.

Summary

Type of Cancellation Refund Outcome Call+1(866)-228-3050

Cruise line cancels your sailing Call+1(866)-228-3050 Full cash refund required by FMC

You cancel early (before final payment & refundable fare) Cash refund (minus any non-refundable deposit)

You cancel late (closer to sailing) Call+1(866)-228-3050 Partial or no cash refund; often FCC

Non-refundable fare/deposit No refund on deposit even if canceled early

Prepaid extras Usually refundable separately
